1. Colleges and universities to promote inter-continental flow of ideas and knowledge

1.1 CUHK and PKU Co-Host the Second Sino-US University Presidents' Dialogue (The Chinese University of Hong Kong; October 1, 2024)

Building on the success of the inaugural event hosted at the Chinese University of Hong Kong (CUHK) in the end of 2023, CUHK and Peking University (PKU) co-organized the second Sino-US University Presidents' Dialogue at the University of Chicago on September 23, 2024. This event aimed to enhance academic exchange and collaboration between Chinese and American universities. Distinguished speakers from China's C9 League, CUHK, the University of Chicago, Harvard University, Yale University, and the University of California, Los Angeles, among others, participated in discussions focused on strengthening academic partnerships and exploring the transformative impact of AI and emerging technologies on higher education. Their conversations aimed to enrich learning experiences, boost productivity, and promote inclusivity and accessibility in academia.

2.2 New International Research Laboratory to Address Treatment-Resistant Cancer (The University of Melbourne; November 7, 2024)

The University of Melbourne and France's National Centre for Scientific Research (CNRS) will establish a new International Research Laboratory in Melbourne, further strengthening their existing collaboration. The laboratory will expand upon the work of Professor Frédéric Hollande from the University of Melbourne and Dr. Patrick Mehlen of CNRS, Lyon, focused on cancer research. Led by Professor Hollande and based at the Victorian Comprehensive Cancer Centre (VCCC), the joint laboratory aims to accelerate research discoveries and support clinical trials between the two countries. A *Letter of Intent* was signed at the VCCC. Professor Hollande highlighted that the lab will address key genetic and non-genetic mechanisms that enable cancers to adapt

continuously, driving treatment resistance in tumours with poor survival outcomes, such as metastatic colorectal and pancreatic cancers.

2.5 France Joins Hyper-Kamiokande International Scientific Research Project (The University of Tokyo; November 26, 2024)

The National Institute of Nuclear and Particle Physics (IN2P3) in France, the High Energy Accelerator Research Organization (KEK), and the University of Tokyo (UTokyo) have signed a *Memorandum of Understanding* (MoU) to advance the Hyper-Kamiokande (HK) international scientific research project. The HK detector, currently under construction in Kamioka, Hida City, Japan, is set to begin operation in 2027. France becomes the fifth nation to sign the MoU, following Poland, Spain, Italy, and Canada. French participation in the project is led by ILANCE (CNRS-UTokyo International Research Laboratory), LLR (Ecole Polytechnique), and LPNHE (Sorbonne Université).

3.5 Cambridge Researchers Develop AI to Think Like Scientists Using

Diverse Datasets (University of Cambridge; December 2, 2024)

Recently, a team of researchers, including those from the University of Cambridge, has made significant progress in training AI models to identify and apply transferable knowledge across disciplines to advance scientific discovery. The initiative, known as Polymathic AI, leverages technology similar to that behind large language models like OpenAI's ChatGPT and Google's Gemini. However, instead of processing text, these models are trained using diverse scientific datasets spanning astrophysics, biology, acoustics, chemistry, and fluid dynamics. This approach equips AI with cross-disciplinary scientific understanding, enabling it to generate insights and solutions across multiple fields.

3.6 Oxford and Edinburgh Researchers Develop Framework for Biodiversity Credit Markets (University of Oxford; December 12, 2024)

Ecologists from Oxford University and the University of Edinburgh have co-developed a new framework to classify how biodiversity credit operators define and measure units of nature. Their analysis highlights the challenges and risks of relying too heavily on biodiversity offsetting as a funding mechanism for nature recovery. The study examines how companies are quantifying biodiversity, detecting positive outcomes, and linking conservation actions to investment. This research is the first in a new series honoring Professor Dame Georgina Mace, whose work has been instrumental in shaping global conservation policy.

3.7 University of Queensland Licenses Ultrasound Therapy for Alzheimer's to New Startup (University of Queensland; December 17, 2024)

A groundbreaking ultrasound therapy with the potential to restore brain

function in people with Alzheimer's disease has been licensed to Ceretas, a new startup spun out of the University of Queensland (UQ). Developed by Professor Jürgen Götz at UQ's Queensland Brain Institute, the technology will be advanced toward clinical application. The therapy harnesses targeted sound pressure waves to enhance neuronal signaling and clear harmful protein buildup associated with Alzheimer's. Ceretas aims to validate the system for treating Alzheimer's and other neurodegenerative diseases, bringing this innovative approach closer to real-world medical use.

4. Colleges and universities to promote people mobility including scholar or student mobility

4.1 Université PSL Launches Global University Academy as Part of New International Solidarity Action Plan (Université PSL; September 12, 2024)

Université PSL has launched the Global University Academy, an international training program aimed at supporting refugee and displaced students near conflict-affected regions. This initiative is part of PSL's broader international solidarity action plan, which includes a dedicated solidarity fund to assist students, teachers, and researchers impacted by conflicts. The Global University Academy, a collaboration among European, African, and American universities, seeks to enhance refugees' access to higher education by offering bridge and undergraduate courses within 18 months. PSL is the sole French member of this consortium, working to develop locally relevant courses, establish mutual recognition of credits, and ensure long-term financial support for participants.

4.2 AI Summer Program for Social Projects at LMU (University of Munich; October 10, 2024)

These data science teams utilized machine learning to address societal challenges. Fellows from diverse backgrounds collaborated to develop solutions, demonstrating the power of AI in resolving environmental and humanitarian issues.

4.3 Black Hole Physics Workshop Brings Together Students from Across Pakistan (King's College London; October 14, 2024)

Students from across Pakistan gathered for an intensive, week-long workshop on black hole physics, led by Dr. Damián Galante, a Research Fellow in the Department of Mathematics (King's College London), and hosted at Fatima Jinnah Women University in Rawalpindi. The workshop was part of the "Physics Without Frontiers" program, run by the UNESCO-funded International Centre for Theoretical Physics (ICTP), which aims to train and inspire physics and mathematics students in the Global South. This initiative connects over 100 researchers with young talent worldwide, providing free courses that have reached more than 10,000 students. Each program is designed to offer hands-on training, lectures, and industry engagement, fostering diversity in physics and mathematics research. Throughout the week, Dr. Galante and Dr. Tibra Ali from BRAC University in Bangladesh delivered lectures and problem-solving sessions on general relativity and quantum mechanics to a group of undergraduate and master's students, helping to nurture future scientific leaders.

4.5 CityUHK and Lucy Cavendish College Launch Pioneering Scholarship Program (The City University of Hong Kong; October 31, 2024)

The City University of Hong Kong (CityUHK), in collaboration with Lucy Cavendish College at the University of Cambridge, has introduced a pioneering five-year scholarship program – the first of its kind among Hong Kong universities. The CityUHK-Lucy Cavendish College Scholarships are designed to attract top master's degree students from CityUHK and around the world to pursue their studies at the University of Cambridge. The scholarships will provide funding of HK\$10 million (GBP one million) annually, supporting up to 20 students each year. Each recipient will be awarded a full scholarship to pursue a one-year, full-time master's program at the University of Cambridge.

5. Non-university organizations to promote global common good

5.1 2024 World Vocational Education Conference Unveils Global Initiatives for Skills Development (Ministry of Education of China; November 22, 2024)

The 2024 World Vocational and Technical Education Development Conference, themed "Innovation Empowers the Future, Skills Enlighten New Lives," commenced on November 21 in Tianjin, China. A key highlight of the event was the establishment of the World Vocational and Technical Education and Training League. The conference brought together leaders from education and related sectors across 32 countries for a ministerial roundtable, where they discussed and adopted the *Tianjin Consensus on the Development of World Vocational and Technical Education: A Declaration of 32 Ministers*, outlining a shared global vision for vocational and technical education. The conference aimed to provide six key international public goods: hosting the global conference, launching the education league, presenting the World Vocational Education Awards, organizing the World Vocational College Skills Competition, holding a thematic exhibition, and introducing an international journal focused on vocational education.
